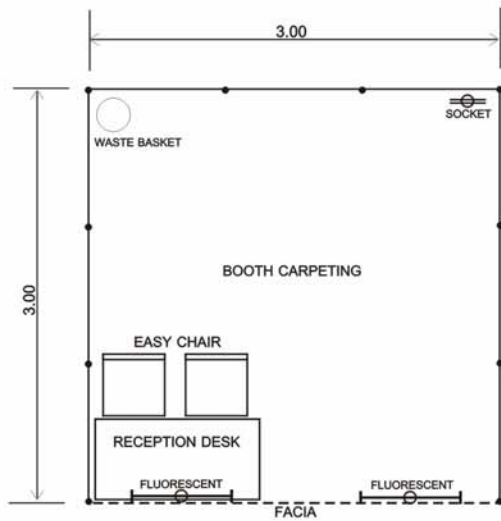
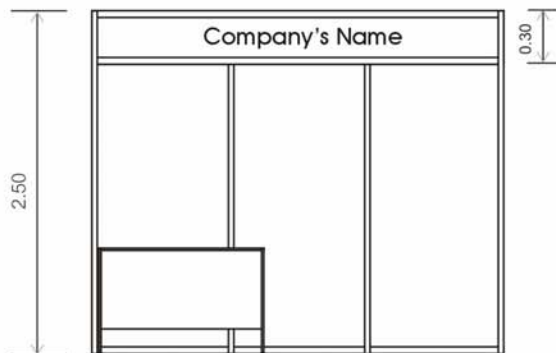

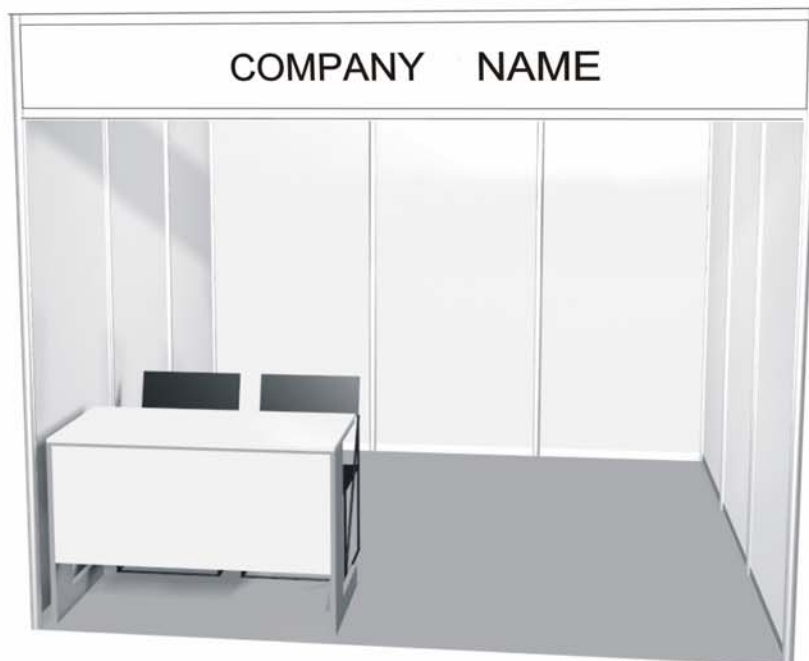


**FLOOR PLAN SCALE 1:50**
